How Masons Changed History:

When we realize how many Presidents, Prime Ministers, Senators, Representatives, Governors, Mayors and Generals were Masons, we find a big disproportion when compared to any other fraternity or society.

Some people think that Masonry is so powerful that it can elect the people it wants, but that is not the fact.

Actually, Masonry is a school of leadership. Let's understand how it works, in brief.

Historically young Masons are fairly educated men in their 20's, 30's, and 40's, from good families, and very committed to their future.

First, a candidate to Masonry has to be recommended by two Brothers who know him well and attest that he is of high moral standards, industrious and temperate. But as this is not enough, the Lodge will investigate the candidate and only if found acceptable to all members of the Lodge will he be received.

Afterwards, he will go through a series of teachings and degrees where he will be inculcated with the purest principles of morality, intellectuality, and spirituality, meeting with his older Brother before, between, and after the Degrees for coaching. Can you believe how much better a good man will become after his journey where any discouragement he might have had about the trend of our society will be dissipated, where he will find people concerned with the problems our society faces and will look for high standard solutions ?.

In Masonry he will widen his view and his sense of belonging and responsibility towards his Brothers as a first step, society and country as a second step, and humanity as the third.

He will understand that all men are created equal, entitled to one vote; that government of the people, by the people, and for the people is the only form of government acceptable, that everybody is entitled to his freedom of thinking, expression, and conscience.

In practical terms he will learn how to elect officers for his Lodge, done yearly, and experiencing the feedback of his vote, learning from it. He will learn how to work with others at the same level, how to respect authority, and how to handle authority when given him by the Brothers. (To be continued next month)
