The resolution proposing that a person must have given back his MM catechism prior to being elected as WM was DEFEATED.

The resolution that the 2004 Handbook of Recommended Floor work Procedures be adopted as the official floor work for Florida was DEFEATED.

The resolution that would permit an elected officer to serve as an appointed officer in another Lodge where he serves as a Plural member was DEFEATED.

The resolution to change the wording in the Digest as it pertains to how annual dues are collected was DEFEATED.

The resolution that would give the WM power to remove an appointed officer for good cause was DEFEATED.

And the resolution to create a standing Membership Committee was DEFEATED.
