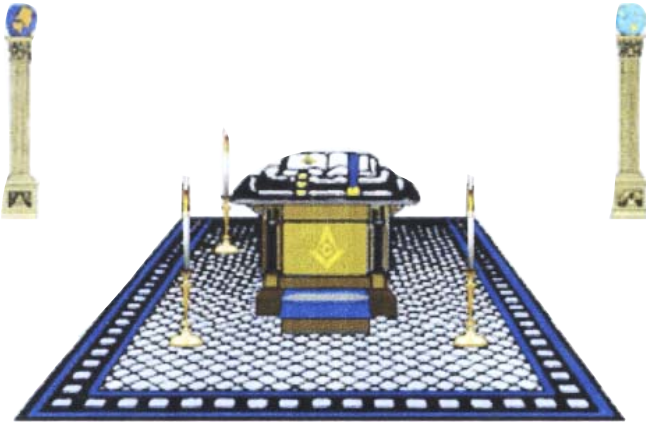

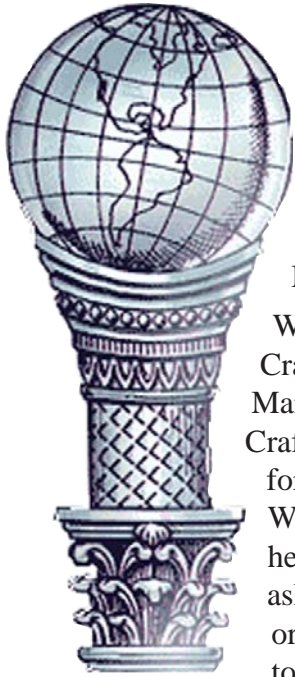

Bylaws Change Notice

This is to notify the membership of a Bylaws change that must be read at three business meetings before it is voted on.

On March 10, the audit committee suggested the dues should be raised. We receive \$3,700 in dues, but our expenses are around \$10,000 each year. The following motion was made and will be read at the next three meetings.

MOTION; The dues shall be changed from \$44.50 to \$75.00 per year, and the lifetime membership will change from \$500 to \$750, starting in January 2009.

The following is not part of the motion and is a way for us to help any member who is not financially able to pay the new dues amount should the motion pass.
