# RULES GOVERNING ADMISSION OF CHILDREN INTO THE MASONIC HOME AND SCHOOL

While researching old papers for local Lodge histories, I stumbled upon these guidelines for the admission of a child to the Masonic Home and School as Revised and Passed by Board of Directors July 14, 1946. (Reprinted below)

From what I have gathered, listening to many discussions between Master Masons regarding the Home and School, I feel that if these same guidelines were strictly followed today, the Home and School would be financially sound and strongly supported by all Texas Masons.

In almost every discussion, I have heard about the Home and School, the complaint is always made that the home and school was created for orphaned children of the Master Masons of Texas and it is felt that the intent was wrongly altered against the wishes of the majority to allow enrollment of children of non-Masonic parents.

- 1. An application for admission of a child into the Home must be made by the Lodge of which the father is or was at the time of his death a member in good standing. An application will not be considered other then by such Lodge.
- 2. The applicant, to be admitted, must be the child of a Master Mason in good standing in a Subordinate Lodge in Texas, and must come under one of the following classifications:
  - (a) The applicant's father must be deceased.
  - (b) The applicant's father must be incurable ill o r in-sane.
  - (c) The applicant's mother must be deceased or in curably ill or insane, and the father unable to provide a home for the applicant.
  - (d) The applicant must be deprived of a home be cause of the desertion of the mother, all cases to b e considered separately and upon individual m e r i t; and in no case will an applicant from a broken home be admitted until a decree of divorce has been granted.

NOTE: A child legally adopted by a foster father is to be considered on the same basis as a child of a natural father.

NOTE: The Masonic Home and School cannot take a child for pay.

- 3. A child under three years of age or one or one who has reached it's thirteenth birthday will not be admitted.
- 4. A child who has property sufficient to maintain and educate it will not be admitted.

(It is not the function or purpose of the Home to care for a child in order that an estate may be conserved.)

5. A child who has a close relative or relatives able and willing to care for it will not be admitted.

(After all, the normal home is the best atmosphere in which to rear a child. If close relatives are able and desire to care for the child it is best that they should assume the responsibility. This will give the Home the chance to care for some child not so fortunately situated.)

6. A child afflicted with tuberculosis or any other communicable disease, or who is deaf, dumb, blind, or of unsound mind will not be admitted.

(It is the function of the home to rear and educate normal children. It is unsound educational policy to try to train normal children along with children who are mentally, physically, or morally defective.)

- 7. Any child who develops vicious habits or becomes insubordinate will be dismissed from the home.
- (It is not the function of the home to assume the work of a reformatory. It is unfair to good children to subject them to the influence of a few vicious residents.)
- 8. Should a mother who has a child in the Home marry it is presumed that she and her husband will assume the normal responsibility of parents and relieve the Home of the care of her child to the end that more needy and helpless children may be received.
- 9. A mother who persists in violating the visiting regulations, or who criticizes and finds fault with the Home to such an extent that any child of hers becomes dissatisfied and hard to control, shows so little appreciation of the Home's service, and so little of the spirit of co-operation as to become a positive disturbing factor in the life of the Home. When, by conference with such mother, her co-operation cannot be secured, each child will be returned to her.

#### The 1723 Constitution

In 1723 Brother James Anderson's Constitutions of the Freemasons appeared. It was purported to have been compiled from old Manuscripts and Records, many of which have doubtless been lost. Brother R.F. Gould calls attention to "three striking innovations" in the 1723 Constitutions, to-wit: "It discards Christianity as the (only) religion of masonry, forbids the working of the Master's part in private lodges, and arbitrarily imposes on the English craft the use of two compound words, Entered Apprentice and Fellow Craft, which had no previous existence in its terminology." Brother Gould believed that at the formation of the grand lodge in 1717 it inherited from the time immemorial Masons only two degrees, and that the fellow Craft and Master Mason were one.
