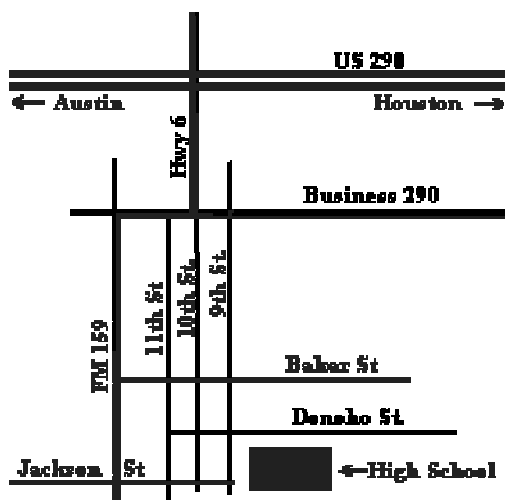
Right Worshipful Arvol Willingham, The Grand Treasurer of the Grand Lodge of Texas will be the featured speaker and provide the entertainment.

The above story was told long ago by great great grandma Susan Jane Garrett. This Saturday, if she had been in Pine Island she would have heard those canons again, from 5 miles away at the Liendo Plantation reenactment where the soldier from each side and the visitors ate about 45 pounds of baked stuffed potatoes and a dozen briskets cut up for bar-b-que sandwiches.

## It's Masonic Law In Texas

### “Art. 393a. Solicitation

This Grand Lodge supports and practices the ancient custom and usage among Masons that a man is required to present himself for the Degrees of Masonry of his own free will and accord. At the same time, it acknowledges to all Masons of its obedience, **that it is permissible to extend a neutrally-worded invitation to petition for the Degrees of Freemasonry to a man whom you have strong reason to believe is of good moral character and reputation, who is otherwise qualified to petition under the laws of the Grand Lodge of Texas.** After answering the non-Mason's questions about the Fraternity (those proper to be discussed) and explaining the procedure for petitioning, the candidate should be left to make his own decision and to proceed of his own free will.”

## Withdrawal Of Petition

It is a law of Freemasonry in the United States of America that a petition for initiation having been presented to a lodge, cannot be withdrawn. It must be submitted to the action of the Lodge. The rule is founded on prudential reasons. The candidate having submitted his character for inspection, the inspection must be made. It is not for interests of freemasonry (the only thing to be considered) that on the prospect of an unfavorable judgment, he should be permitted to decline the inspection, and have the opportunity of applying to another lodge, where carelessness or ignorance might lead to acceptance. Initiation is not like an article of merchandise sold by rival dealers, and to be purchased after repeated trails, from the most accommodating seller.
