

WHY DO WE WAIT?

This morning, I read the local newspaper from the town in Connecticut where I had resided before moving to the Cincinnati area. It contained numerous eulogies for the Chief of Police who succumbed to a heart attack a few days ago. He was fifty four years old. These words were beautifully written and consumed over two pages of the newspaper. While reading these eulogies which were filled with praise for this individual, his love for his family and his friends, his sense of humor, his dedication, his devotion to duty and to the town in which he served, his compassion for others, and his assistance to those who called upon him, I realized he truly was an honorable man, and a dedicated leader. He will be missed by many. Upon reflecting on these eulogies, a thought came to me. How many individuals do each of us know personally, especially family members, or friends of ours, who fit the same description as that popular Chief of Police? I'll bet we all know some one. During the period of time we have known these individuals, how many times have we mentioned the way we feel towards them? How many times do we express our inner most feelings to them, shake their hand or even give them a loveable hug? Have we hugged someone

May the Grand Architect above watch over us in the coming year, keep us health and safe.



WORKING TOOLS

We are all familiar with the working tools of our craft and the lessons they teach and remind us of. But, as man has evolved so have the working tools he uses. Here's a list of modern working tools and their most common usefulness.

DRILL PRESS: A tall upright machine useful for suddenly snatching flat metal bar stock or wood out of your hands so that it smacks you in the chest and flings your drink across the room, denting the freshly-painted project which you had carefully set in the corner where nothing could get to it.

WIRE WHEEL: Cleans paint off bolts and then throws them to some unknown place with the speed of light. Also removes fingerprints and hard-earned calluses from fingers in about the time it takes you to say, well you know what you said.

<u>SKIL SAW</u>: A portable cutting tool used to make studs too short.

<u>PLIERS</u>: Used to round off bolt heads. Sometimes used in the creation of blood-blisters.

<u>BELT SANDER</u>: An electric sanding tool commonly used to convert minor touch-up jobs into major refinishing jobs.

<u>HACKSAW</u>: One of a family of cutting tools built on the Ouija board principle... It transforms human energy into a crooked, unpredictable motion, the more you attempt to influence its course, the more dismal your future becomes.

<u>VISE-GRIPS</u>: Generally used after pliers to completely round off bolt heads. If nothing else is available, they can also be used to transfer intense welding heat to the palm of your hand.

OXYACETYLENE TORCH: Used almost entirely for lighting various flammable objects in your shop on fire.

<u>TABLE SAW</u>: A large stationary power tool commonly used to launch wood projectiles for testing wall integrity.

<u>HYDRAULIC FLOOR JACK</u>: Used for lowering an automobile to the ground after you have installed your new brake shoes, trapping the jack handle firmly under the bumper.

<u>BAND SAW</u>: A large stationary power saw primarily used by most shops to cut good aluminum or wood into

smaller pieces that more easily fit into the trash can after you cut on the inside of the line instead of the outside edge.

TWO-TON ENGINE HOIST: A tool for testing the maximum tensile strength of everything you forgot to disconnect.

PHILLIPS SCREWDRIVER: Normally used to stab the vacuum seals under lids or for opening old-style paper-and-tin oil cans and splashing oil on your shirt; but can also be used, as the name implies, to strip out Phillips screw heads.

STRAIGHT SCREWDRIVER: A tool for opening paint cans. Sometimes used to convert common slotted screws into non-removable screws and butchering your palms.

PRY BAR: A tool used to crumple the metal surrounding that \$50,00 clip or bracket you needed to remove in order to replace a 50 cent part.

HOSE CUTTER: A tool used to cut hoses to short.

HAMMER: Originally employed as a weapon of war, the hammer nowadays is used as a kind of divining rod to locate the most expensive parts adjacent to the object we are trying to hit.

<u>UTILITY KNIFE</u>: Used to open and slice through the contents of cardboard cartons delivered to your front door; works particularly well on contents such as seats, vinyl records, liquids in plastic bottles, collector magazines, refund checks, and rubber or plastic parts. This tool is especially useful for slicing work clothes when you put it your pocket, but only while in use.

(AND A PERSONAL FAVORITE) Any handy tool that you grab and throw across the garage while yelling, again you know what you said, at the top of your lungs. It is also, most often, the next tool that you will need and won't be able to find since you threw it to parts unknown.





Some of discoveries and contributions to mankind made by the Masonic Medical Research Laboratory* include the following.

- Discovered the M cell, a unique sub-population of cells in the heart that revolutionized our understanding of the function of the heart in health and disease
- Uncovered the cellular basis for the J wave and T wave of the ECG, thus providing cardiologist a more accurate means of diagnosing and treating heart disease
- Provided knowledge essential for implementation and advancement of devices like the pacemaker, implantable cardioverter defibrillator (ICD) and automatic external defibrillator (AED)

The list goes on and on with the new Stem Cell Center focused on regenerative medicine and development of human models of disease using an exciting new technology employing induced pluripotent stem cells (iPS), which precludes the need for use of embryos.

They have successfully converted skin cells from patients with sudden cardiac arrhythmia syndromes to generate induced pluripotent stem (iPS) cells and then transform these cells into heart cells, thus generating human models of these life-threatening syndromes needed to develop new treatments and cures.

As you can see my Brothers, the Masonic Medical Research Laboratory is conducting innovative research into identifying mechanisms of disease with a focus n development of therapeutic interventions and cures. We are a part of this a very important partnership with the Masonic Medical Research Laboratory, because these studies lead to new discoveries and a better quality of life for all. Below is something you're likely to find interesting. There has long been a friendly debate about the terms, Sublime Degree of a Master Mason, and Sublime Degree of Master Mason. The following does not settle the discussion, but it does provide some useful knowledge of the degree, and also something to think about. It comes from "Freemasons' Guide and Compendium;" a very good book to have for Masonic learning.

THE SUBLIME DEGREE of a MASTER MASON

It is believed that the phrase "the Sublime Degree of a Master Mason" first occurs, in the year 1754, in a certificate drawn up by the Grand Lodge of Ireland, relating to a lodge at Lurgan, No. 134, Irish constitution, and that it was used by another Irish lodge, that of the Royal Scots, No. 11, in 1762.

In England the phrase was used in 1767 by the Lodge of Friendship No. 6, but did not come into general use in lodges under the Premier Grand Lodge until near the end of the eighteenth century; but where we do find it, there we also find as a rule evidence of the 'Antients' influence. In 1760 Thomas Dunckerley, as Master of a lodge held aboard the *Vanguard*, signed a certificate (the original is in Quebec, a photograph is in Grand Lodge Library) to the effect that a Fellow Craft "having sustasin'd with Strength, Firmness, and Courage, the most Painful Forks, and Severest Tryalls, we gave unto him the most Sublime Degree of Master."

In Bristol in 1768 a lodge, founded and erased all within the twelve months, gloried in the name of the Sun Lodge of Perpetual Friendship, No. 421, and in the July of its short life its minutes refer to the Sublime of a Master Mason, and, in the month following, to the Sublime degree of a Royal Arch Mason. The St John's Lodge of Henley-in-Arden, which had a few years of existence beginning in 1791, at one time called the Master Mason's Degree 'honourable,' or 'respectable.'

So far as Scotland is concerned, we learn that in the eighteenth century the Third Degree was usually denominated the "High Degree of a Master Mason," but in Lodge Holyrood House, according to R. S.

Lindsay's history of the lodge, the degree had among its various designations, between 1776 and 1778, the "Honourable Degree," the "High and Honourable Degree," the "Noble and Honourable Degree," the Stupendous Degree" (of a Master Mason).

Reference has just been made to a' respectable' degree. More than one lodge applied to the Third Degree, as also to Master Masons, that old-fashioned adjective, so peculiarly Masonic, so commonly misunderstood. The Candidate is early advised to dedicate himself to such pursuits as may enable him to be 'respectable' in life—that is, he should so comport himself as to earn the esteem and regard of those who 'look upon' him, that being the original meaning of the word 'respect' and the meaning borne by it at the time when the word 'respectable' was brought into the ritual.

Such perfect lodges there may be But none of them are known to me;


Yet, still I'll work and pray and plan
