If he has an initial only, then put the letter and circle it, thus (B); example, "John (B) Smith," or "John NMN Smith". Print or type FULL NAME where first required on the line at the top of this form.
- 3. The correct last names must be shown. Show the first, middle, and last names before marriage. If not married, show single, widower, or divorced.
- 4. The residence of a petitioner is the place where he ACTUALLY RESIDES. Do not give a post office box number as residence. Give house number, street, city or town, and state.
