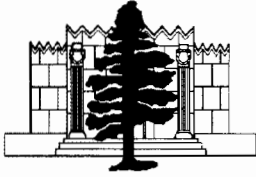

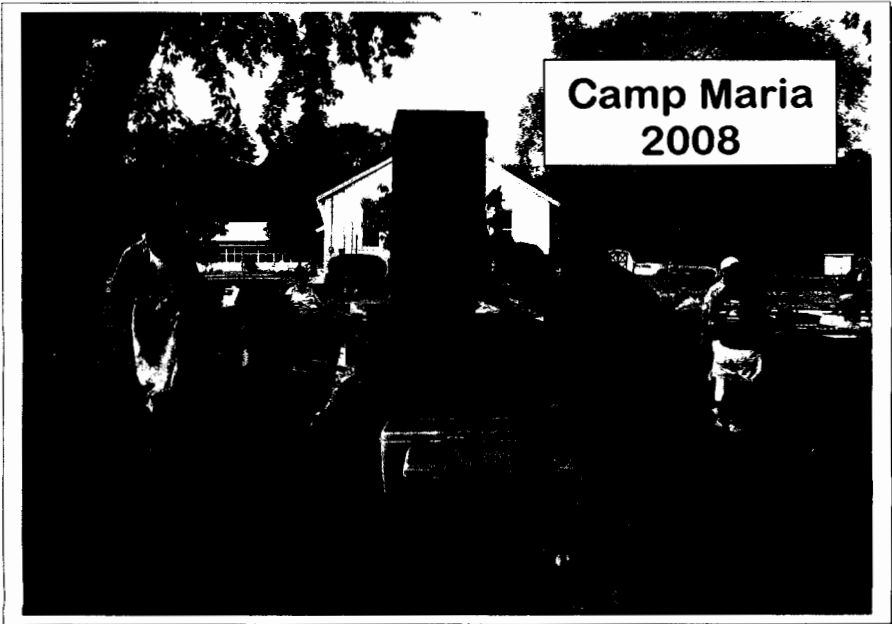
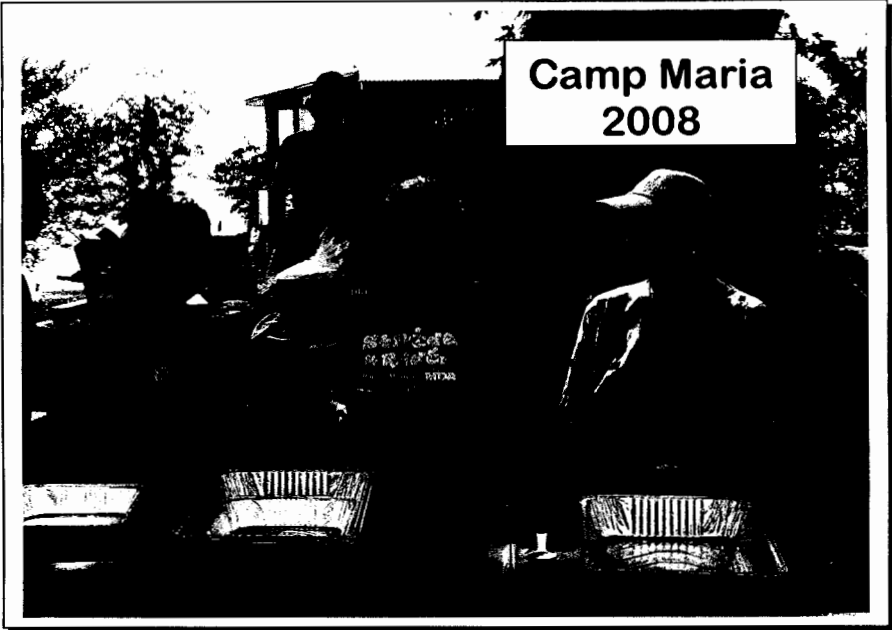
## *The Scribe's Corner*

TEMPLE FOREST 136  
MERGER**

The Executive Boards of both Montgomery and Temple Forests voted to merge on 1 January 2009. This merger was requested by the Executive Board of Temple Forest and is contingent upon approval by both Forests membership and the Supreme Forest.

This merger will not constitute a name change nor will Montgomery's by laws be changed. All members of Temple Forest have life membership and TCF Life membership. Funds received from Temple Forest will offset the expenses incurred for the additional 77 new members.

Supreme Director Norman Clark, Region Number two will request at the Board of Directors meeting on 20 September that Montgomery Forest and Temple Forest be permitted to merge contingent on the following:
