

# The MDA has just announced \$9.9 million in funding for 34 new research projects.

Included among the 34 are 24 research grants for established, independent investigators; a research infrastructure grant to fund the development of computational tools that can integrate and analyze complex amyotrophic lateral sclerosis (ALS) data sets; and two grants to be used to establish clinical research networks for facioscapulohumeral muscular dystrophy (FSHD) and limb-girdle muscular dystrophy (LGMD).

## For Duchenne muscular dystrophy (DMD):

Researchers in Los Angeles are developing nanoparticles as an alternative approach to the delivery of therapies based on gene editing, gene replacement and gene silencing. Nanoparticle-based delivery has the potential to be more accurate and effective than the current adeno-associated virus method used in gene therapy trials.

## For ALS:

Scientists in Belgium are studying the role of histone deacetylase inhibitors in mouse models as a potential therapeutic approach for preserving the motor axon in people with ALS.

### For mitochondrial myopathy:

In New York, researchers are preparing an open-label expanded access trial of a deoxynucleoside therapy for a type of mitochondrial myopathy caused by thymidine kinase 2 (TK2) deficiency.
