By-Laws Socastee Chapter # No. 301 April 25, 1968 October 27, 2008

# ARTICLE I

### Name, Number, and Location

The name of this Chapter shall be Socastee Chapter, 301, Order of the Eastern Star of South Carolina, located in the Socastee area of Myrtle Beach, South Carolina, under the jurisdiction of the Grand Chapter of South Carolina, Order of the Eastern Star.

### ARTICLE II Grand Chapter By-Laws and Ritual to Prevail

The laws, rules and regulations as contained in the Grand Chapter By-Laws governing Subordinate Chapters and the Ritual, hereby becomes a part of these By-Laws and this Chapter shall be governed accordingly.

# ARTICLE III

### Meetings, Time and Place

Section 1. Stated Meetings

Stated Meetings of this Chapter shall be held on the fourth Monday of each month at 7:30 PM except December. The December meeting shall be held on the third Monday at 7:30 PM. Upon a vote of the Chapter, the Chapter may suspend meetings in July and August.

This sentence was added to allow the Chapter to not go dark automatically during the summer.

Section 2. Special Meetings

Special Meetings may be called pursuant to Grand Chapter By-Laws Article III, Section 2 (c), page 69.

# ARTICLE IV III

### Fees and Dues

#### Section 1. Fees

The initiation fee of this Chapter shall be \$40.00 **\$45**, which shall accompany the Petition. \$1.00 of the fee **A fee of \$1.00** shall be designated and remitted to the International Temple Fund. The fee for affiliation shall be \$5.00 which shall accompany the Petition. A copy of the Ritual and By-Laws of this Chapter and Grand Chapter shall be presented to new members upon the completion of the degrees.

We are currently spending \$40.50 when a new member comes into the Chapter. Raising the fee to \$45 would cover our expenses. The \$1 fee for the International Temple Fund is not optional.

### Section 2. Dues

The dues of this Chapter shall be \$20.00 **\$18 plus Grand Chapter per capita** per year, payable in advance on or before the first day of April each year. A new member receiving the degrees shall pay their regular dues of \$20.00 **prorated at \$1.50 per month** on or before receiving the degrees and will be issued their dues card **at the time of** initiation on **upon** the signing of the By-Laws. , unless, the degrees are received after September 1<sup>st</sup>..., in which case they will pay only \$10.

Changing the wording of dues will allow for future increases in Per Capita dues without our Chapter having to revise bylaws to cover dues and increases by Grand Chapter. A new member coming into the Chapter will have dues pro-rated which will save the member money and allow the Chapter to collect appropriate money due.

#### Section 3. Suspension of Non-Payment

Suspension for non-payment of dues shall be handled in accordance with the Grand Chapter By-Laws - Article X, Section 5, page 10.

This wording was removed to eliminate having to revised our Bylaws if the page changes.

#### ARTICLE V IV

The Secretary's and Treasurer's books shall be audited annually by a committee appointed by the retiring Worthy Matron and a report made on or before the stated meeting in May of each year. No elected Officer shall serve on the audit committee.

This wording clarifies which Worthy Matron is responsible for the audit and that no elected office shall serve on the committee.

#### ARTICLE VI

The Treasurer shall sign on the respective bank accounts of this Chapter. The Secretary shall hold keys to the Post Office Box of the Chapter.

#### ARTICLE VII V

Property of Socastee Chapter, 301, may not be loaned to any organization or individual without prior approval of the Chapter.

# ARTICLE VIII VI

## Expenses

#### Section 1.

Funds deposited in the Coastal Federal Savings and Loan Association of Myrtle Beach, shall not be withdrawn for any purpose other than repairs, improvements to Chapter room, a new Temple or unless an emergency arises and approved by the vote of the Chapter.

#### Section 2 1. Grand Chapter

At the last stated meeting to be held before each **prior to the** annual Grand Chapter session, it will be brought before the Chapter and decided upon a to the amount of money to be given to the Worthy Matron, Worthy Patron **or their proxy** Associate Matron and Associate Patron, who attends Grand Chapter in the current year in person, **shall be given \$100 each if they attend Grand Chapter**.

Sets forth when, for whom, and how much money shall be given to the Worthy Matron/Worthy Patron or their proxy for attending Grand Chapter. In the past, a motion was made for the expenditure. This has not been done the past three years as the Worthy Matron/Worthy Patron did not attend Grand Chapter. This year, no motion was made and no money expended.

#### Section 4 2. Sickness and Cheer

Cards will be sent to all ill members; also flowers may be sent to the seriously ill as determined by the Worthy Matron and Chairman of the Sick and Cheer Committee. Flowers or Memorials will be sent to the immediate family in case of death.

Birthday cards shall be sent to members. In case of the death of a member or a member's immediate family (spouse, parent, or child), a Memorial in the amount of \$25 will be made in their honor. The Chairman shall be advanced \$50 at the beginning of each Chapter year for the purchase of cards and stamps. Any additional expenses will be reimbursed. Any funds remaining at the end of the Chapter year shall be returned to the Chapter along with all receipts for expenses.

#### Section 3. Ways & Means

The Chairman of Ways & Means shall be advanced \$200 at the beginning of each Chapter year for the purchase of items necessary to start a fundraising project. At the conclusion of each fundraiser, all receipts shall be submitted to the secretary. The Ways & Means Chairman shall replace expended funds from the profit so that a Ways & Means fund of \$200 shall be maintained. At the end of the Chapter year, the \$200 shall be returned to the Chapter.

#### Section 4. Installation

In March, the incoming Worthy Matron shall be given \$100 for the Installation of Officers. Receipts shall be submitted.

These three paragraphs allow for the Chairman of the respective committees and the incoming Worthy Matron to receive reimbursement for expenses as specified in each paragraph.

#### Section 5.

Any major new business to be brought up at a regular stated meeting is to be presented to the Worthy Matron or Secretary one hour prior to the stated meeting for preparation of the agenda.

#### Page 6

### Section 5. Secretary and Treasurer Fees

The Secretary shall be paid \$50 and the Treasurer shall be paid \$25 at the end of each chapter year, a salary based on the vote of the Chapter.

This wording was added to eliminate the need to have a motion each year. The secretary and treasurer are essential to the operation of the Chapter. They spend their own time in keeping our books and handling our correspondence and should be paid.

#### Section 6.

The Secretary will present to the Chapter an itemized statement of each bill due for payment and for the purpose of the Chapter.

### Section 6. Chapter Newsletter

The Worthy Matron, or her designee, may publish a monthly newsletter. Postage and printing costs shall be paid by the Chapter.

Communication is essential for any organization. This reimburses the Worthy Matron or her designee to publish a Chapter newsletter and receive reimbursement.

### Section 7. Official Visit

On the occasion of their Official Visit, monetary gifts shall be given.

Inspecting Grand Officer	\$25.00
Worthy Grand Patron	\$15.00
District Deputy	\$15.00

This was moved from the guidelines section and places it in the Expenses Section. These items will not require a vote of the Chapter. This brings monetary gifts up to a modern amount. Other positions were deleted from the list as the committee felt that these were the only three who should receive a monetary gift.

#### Section 8. Jewels

The Worthy Matron and Worthy Patron shall be given \$100 and \$75 respectively toward their Past Matron and Past Patron jewel.

This will authorized the Chapter to pay toward the Worthy Matron/Worthy Patron jewels.

#### ARTICLE IX

Long white dresses shall be worn by the Lady officers for Initiation Inspection, and Installation, except for the Worthy Matron. The Worthy Matron may select a color of her choice. Men shall wear tuxedos or suits. Star points may wear the color of their point (station).

# ARTICLE X VII

#### Miscellaneous

#### Section 1.

Each Worthy Matron shall present a proposed budget for the Chapter's decision approval no later than the  $2^{nd}$  May stated meeting of her year.

This establishes a timeline for a budget to be presented to the Chapter for approval.

#### Section 2

Property of Socastee Chapter, 301, may not be loaned to any organization or individual without prior approval of the Chapter.

# ARTICLE XI VIII

### Alterations and Amendments

Alterations, amendments, or revisions may be made in these By-Laws, provided such action is handled in accordance with the Grand Chapter By-Laws, Article IV, Section 6, page 98. A with a two-thirds majority vote of members present is required.

#### COURTESIES

Everyone on the gift list should be included.

## HONORARY

Honorary memberships should be voted on at the regular meeting prior to the official visit.

# LODGING

One nights lodging for the Inspecting Officer, Worthy Grand Matron, and their traveling companion to be provided.

# JEWELS

\$100.00 for Past Matrons jewel and \$75.00 for Past Patron jewel. Jewels to be chosen by retiring matron and patron and ordered by the Chapter Secretary at least four (4) weeks prior to Installation. If cost exceeds the above allowance the additional charge will be assumed by the respective receiver.

# INSTALLATION

The Associate Matron should check with the District Deputy regarding a date then at the February meeting get the Chapter's approval for the date and for a closed or open installation.

#### \*\*\*\*\*\*

Some of the changes were basically moving items from one section to another where it is more appropriate. Some items were removed as it is already required by the Grand Chapter and does not need to be included in Chapter Bylaws.

I would like to thank the members of the Bylaws Committee: Linda Hodges, Bernie Heavey, Billy Simmons, and Naomi Reese for serving on the committee. Their job is not yet done! Once the bylaws have been approved by the Chapter, their duty is to put these changes in the appropriate format and send to the Worthy Grand Matron for approval.
