

# NOBLE, CAN YOU SPAREADIME?

Most of you will not remember, but may have read about it. This is a parody to the phrase "Brother Can You Spare A Dime" created in the days of the great depression. Now, if this heading has stirred your curiosity, that is indeed the intent to do so. Please read on:

Our Shrine Temple is facing some of the same problems that face many organizations. We have increasing costs coupled with declining membership. Without our numerous volunteers, who do the actual work of repairing, rebuilding, general up keep, our problems would be much greater. It is impossible to name names, and I know I would certainly miss a couple, but I am proud of these Nobles who give so much to our Shrine. Even with our volunteer labor, we must buy materials for the various projects. Some say, "Just increase the dues" but I don't see that as the solution to those pressing issues. Increased costs are everywhere; garbage, water, electricity, heat, air conditioning, etc. Many ask, "What are they, doing with the money"? Yet, if a worthy cause is mentioned, we are at the ready to open our wallets and support the endeavor. So here are my thoughts on what we as Shriners are constituted for and how we could solve some of our financial problems.

The Shrine Temple is the place from which all blessings flow and we must keep a financially sound Temple. We exist to support Shriners Hospitals for Children. Without the Temples, we would lose the money raised by our Clubs and Units. It has been said that charity begins at home, and personally, I feel that this is a worthy charity and we need to open our wallets wide. We have 1,931 members in the Nile and if each of us gave a dime a day, we would raise about \$70,000 a year. I realize we would not get a 100% participation, but we can always hope. The acronym for Dime A Day is "DAD" Fund, which we, symbolically are for the children in our hospitals. DAD Fund donations are only dispersed with the consent of the Nobility.

Something has to be done to increase our income. If this sounds like a good idea to you, send in your check to the DAD Fund (Dime-a-Day-Fund)-today. Don't wait until tomorrow, do it now. If any of you ladies are reading this, get out the old sugar bowl, put a dime a day in it and give it to your Noble each year. A dime a day is quite painless, but it would contribute to the financial stability of your Temple So in closing, I will say "Noble, Can You Spare A Dime"?







# Infant Home in time for the Holidays

When four-day old Korbin began running a high fever, his parents took him to the local children's hospital emergency room. Little they know that shortly after Korbin's arrival at the hospital, their newborn infant would be diagnosed with a potentially debilitating disease: Necrotizing fasciitis.

Necrotizing fasciitis is an infection that destroys skin and soft tissue, and can be caused by all different kinds of bacteria, according to Dr. Richard Kagan, chief of staff at Shriners Hospitals for Children® -



Symptoms of necrotizing fasciitis usually begin with a fever. Families usually won't recognize why their child is running a fever. A trip to an urgent care center or hospital emergency room is usually where necrotizing fasciitis is diagnosed after physician evaluation. Hospital admission at a children's hospital is required to treat the sepsis or infection. Surgical debridement is usually required to cut away the skin that has died as a result of the infection.

When the infection is gone and the patient is stable from a medical point of view, it is time to call Shriners Hospitals for Children - Cincinnati.

Kagan said, "When a child with necrotizing fasciitis is stable and infection free. Shriners is here to take care of the wound coverage and management following surgery." A referral to Shriners is necessary in order for the medical staff to determine if the child is stable enough for transfer and the status of the wound.

Korbin spent six weeks in the hospital being treated with antibiotics and surgery to save his life. When discharge was nearing, parents Jade and James Kennedy began looking for help to get Korbin's surgical wound treated.

"A woman from church had a distant family member who was treated at Shriners in Cincinnati," James said. "We looked them up on the Internet and called, and the transfer process started."

We knew when we walked in the door that we were already happy we brought our baby here," said Jade, Korbin's mother. "The staff treated Korbin like a baby and not a diseased animal. I felt like they rolled out the red carpet for us."

Dr. Petra Warner, assistant chief of staff, used a skin graft to cover Korbin's wound and he was recently discharged from

the hospital without complications.

"Shriners Hospital made our family feel amazing. They helped our baby live a normal baby life with cuddles, snuggles and love."
