The Scottish Rite has partnered with the Wabash Valley Community Foundation to create two funds to help preserve the Scottish Rite Temple.

The first fund is the Scottish Rite Project Fund. Members, community members and businesses can contribute to this fund to support renovation projects that involve certain areas of the Sottish Rite Temple. This fund has been used to receive funds for the new roof and to renovate the lower lobby. In the future, the Scottish Rite would like to use this fund to....(The Scottish Rite leadership should prioritize what they want to renovate. For instance—the lobby, the Auditorium, the Stage,—etc.)

The second fund is the Scottish Rite Preservation Fund. This fund allows individuals and businesses to contribute to a permanent endowment. The income from this endowment will be used to assure the preservation of the Scottish Rite Temple.

The Scottish Rite created these funds in the Community Foundation to benefit our members. Contributions to the Scottish Rite Project Fund or to the Scottish Rite Preservation Fund are tax deductible to the extent allowed by law. For some members, their employer may match their contributions to either of these funds.

One 8-ounce box pitted Dates 30 Pecan halves 10-12 slices bacon
