

PETITION FOR THE ORDERS KNIGHTS TEMPLAR



Excerpt from the Statutes of Grand Encampment, Knights Templar of the United States, as amended at Cleveland, Ohio, 1940.

Section 177. Anyone * * * who is a Master Mason and Royal Arch Mason affiliated in both Lodge and Chapter; or who is an affiliated Master Mason, and who has petitioned a Chapter of Royal Arch Masons for the Capitular Degrees, provided, however, that none of the Orders of Knighthood shall be conferred upon said petitioner until he shall have received the Royal Arch Degree; and * * *

Section 178. Every petition for the Orders of Knighthood shall declare the Lodge in which the petitioner received the degrees, the Lodge in which he is affiliated, the Chapter in which he received or is to receive the Chapter Degrees, and also the Chapter in which he is or will be affiliated. * * *
