## FROM THE WEST Senior Warden Larry Duff

MY Brothers "Thank You" for your confidence in electing me as your Senior Warden for 2011. I'm looking

forward to another great year laboring with you and the Officer line.

I also Thank each of you for your support during 2010 during my term as your Junior Warden. To-

gether we accomplished a lot.

Aside from the Junior Wardens duties within the Lodge room, the Junior Warden is responsible for the Lodges kitchen. Your attendance at our Tuesday Breakfasts and Second Sunday Dinners, along with those Brothers who volunteered their time to work in the kitchen made 2010 an outstanding year for Leesburg Lodge.

A Special "Thank You" to my wife Brenda, my niece Tonda, Lady Nina McIntyre, Lady Fran Cartier, Lady Linda Sever, Lady JoAnne Goodkin, Lady Deanna Dean and Lady Elaine Bierly who gave of their time to work the dining room floor and sever as greeters during our Sunday Dinners.

Our goals for 2010 were to improve the kitchen and dining room operations and appearance, average 75 attendees at our Sunday Dinners each month and have a positive cash flow of \$600.00 per month. To achieve these goals we listened to your input and made adjustments each month as we could.

So how did we do, our average attendance for 2010 monthly dinners was 94 attendees, positive cash flow averaged \$750.00 per month. We began 2010 with \$2,800. in the Kitchen Account and ended with \$3800. During the year \$8,000 was transferred with your approval to pay expenses such as Insurance, building repairs, Licenses and other expenses to operate our Lodge.

Additionally over \$4,300 in *donations* was received into the kitchen and dining room in the form of decorations for the dining room, ceiling fans, Coffee and Tea equipment, pantry refrigerator and utensils.

None of this would have been possible without your support and participation. Thank You all and I ask that you continue your support of our Lodge during 2011 and give your support to the new Junior Warden as you did with me.

May God continue to Bless each of you and your families.

At the December 7th, Stated Communications Meeting the following proposed resolution for addition to our Lodge By-Laws was made by 2010 Junior Warden Larry Duff. Discussion on this resolution will be held and vote taken at our January 18th Stated Communications Meeting

PROPOSED BI-LAWS RESOLUTION ON OFFICERS OF THE LODGE JUNIOR WARDEN

## "Kitchen and Dining Room"

WHEREAS, the membership of Leesburg Lodge recognizes the need to establish guidelines that shall provide for effective management and financial support of the Lodge, and

WHEREAS, no formal guidelines are currently found in the By-Laws of Leesburg Lodge relating to the operation of and financial relations of the "KITCHEN" with the Lodge, and

WHEREAS, the Junior Warden, Stewards and Volunteers have been working under approved decisions of the Worshipful Masters, Junior Wardens and membership at Stated Communication Meetings that has occurred over a number of past years,

WHEREAS, the membership of Leesburg Lodge desires that these decisions and actions be made apart of the By-Laws of Leesburg Lodge, subject to necessary revisions at future dates,

THEREFORE BE IT RESOVED, that created shall be Section 6.08 within the By-Laws of Leesburg Lodge, to read:

6.08 The Junior Warden, in addition to other duties, shall be responsible for the management and operation of the Lodges Kitchen subject to the following;

(a) The Junior Wardens duties include coordinating a volunteer Kitchen staff, meal planning, determining portion sizes, managing the preparation of meals, determining a theme for dinners and special events, establishing and maintaining contracts with Lodge approved vendors, marketing, advertising and overseeing Masonic relations relative to the Kitchen. Before and during meals, the Junior Warden oversees prep work and ensures that all meals leaving the Kitchen are consistent in presentation and quality.

(b) The Lodge Stewards under the direction of the Junior Warden shall assist the Junior Warden in the performance of his duties.

© The Junior Warden shall be issued the sum of Two Hundred Dollars (\$200.00) upon taking office by the Treasurer to be utilized for the purchase of food or other needed items to operate the Kitchen. Upon the end of term of office the Junior Warden shall return all unused funds to the Secretary along with any other funds obtained and in his possession.

(d) All funds obtained from food services or Kitchen rental fees are the property of and shall be considered as funds of the Lodge. Funds derived through or obtained by the Kitchen shall be deposited into a banking account separate and apart from the Lodges General Fund, Savings, Charity or Investments. Funds to be deposited into the "Kitchen Account" shall be received by the Secretary, recorded, and forwarded to the Treasurer for deposit within the "Kitchen Account". Funds within the "Kitchen Account" may be used to support the operation of the Kitchen (i.e. purchase of food, repair or acquisition of equipment) or may as needed, by the Lodge to fund and support Lodge operating costs, charities or other Lodge approved activities or necessities.

(e) Funds withdrawn from the "Kitchen Account" shall be by approval of the membership by hand ballot during a Stated Communication Meeting, or by approval of the Worshipful Master in which notification to the membership shall be made at the earliest Communications Meeting. The Junior Warden may purchase food or necessary items with the approval of the Worshipful Master in the event on-hand purchase cash is insufficient to pay for upcoming meals or events.

(f) The Junior Warden may present before the Lodge food service or related vendors for approval of use of their services to enhance the operation of the Kitchen. Chain stores, i.e. Wal-Mart, Publix, Sam's, Costco etc., maybe be used by the Junior Warden for purchase of food and necessary items to operate the Kitchen.

(g) The Junior Warden shall maintain an accounting of funds and donations received, source thereof and expenditures monthly. This report accompanied by receipts of purchase and expenditures shall be delivered to the secretary at or near the first of the following month and maintained in a Kitchen records file by the secretary, a copy of this expenditure report, less receipts, shall be posted on the Lodge bulletin board for membership review. The Junior Warden, Treasurer and Secretary shall quarterly review their records for accuracy and reporting.

(h) As the operation of the "Kitchen" is by volunteers of the Lodge, the Junior Warden, at his discretion, may cease Kitchen operations, with notification to the Worshipful Master, when there are insufficient volunteers to operate the Kitchen. The Junior Warden may solicit volunteers at Stated Communication Meetings, through the Trestle Board, electronic mail or other means available through the Lodge.

(i) Should at a future date a "Kitchen Committee" be formalized such committee shall be chaired by the Junior Warden who shall maintain authority of the Kitchen operations, reporting to the Worshipful Master. (j) The Kitchen shall be operated and under the control of Leesburg Lodge as prescribed by the by-laws of this Lodge. No independent corporation, company association or group shall be permitted to operate the Kitchen on behalf of Leesburg Lodge.

(k) The Kitchen and Dining Room maybe rented or leased subject to membership approved rental/ lease fees, negotiated cost terms or by authorization of the Worshipful Master with consideration for services provided by the Lodge. No rental or lease agreement for use of the Kitchen or Dining Room shall be executed without coordination with the Junior Warden to ensure no conflicts with Lodge related activities.

(1) Appreciating the generosity of the membership, their families and friends, appendant and concordant bodies in the donating of various items to support, maintain and upgrade the Kitchen and Dining Room, the Lodge shall accept donations for the Kitchen and Dining Room only when these donations have been, prior to their donation, been approved by the Junior Warden and a determination of need and usefulness has been made. Any item purchased and brought to the Lodge for use in the Kitchen or Dining Room without prior approval of the Junior Warden shall be considered a donation and not subject to any reimbursement of cost unless approved by the Worshipful Master or by vote of the membership.

(m) As the Senior Warden is chairman of the Lodges "Property Committee", the Junior Warden shall coordinate with the Senior Warden all necessary repairs and/or upgrades of the Kitchen and Dining Room. "Emergency" (immediate operational issues) repairs shall be authorized by the Worshipful Master, non emergency repairs or maintenance resulting in the expenditure of Lodge funds shall be brought before the membership at a Communications meeting for approval of the expenditure of Lodge funds.

(n) The Junior Warden shall be responsible for the cleanliness of the Kitchen and Dining Room. The Junior Warden shall coordinate pest control services with a Pest Control Company approved for use by the Lodge. The Junior Warden shall be responsible for maintaining a current and valid food service license issued by the proper licensing governmental authorities. Reports of Health Department Inspections shall be delivered to and maintained by the secretary.

(o) Any section, paragraph or line that is in conflict with established Rules and Regulations of the Grand Lodge of Florida shall be deemed null and void. Nothing within this By-Law regulation shall be interpreted as to remove or take away the authority of the Worshipful Master or any other officers' duties or responsibilities of the Lodge.

(p) It shall be the responsibility of the Junior Warden to present before the Lodge for approval amendments that keep this section of Leesburg Lodge No. 58 By-Laws current.

End, no further proposed.





### "DISCOURSE" Vol. I Issue 8 R∴W∴ JORGE L. ALADRO Senior Grand Warden, Grand Lodge of Florida "Proficiency, a Double Standard?"

### Dear Brothers:

Proficiency is another subject we often discuss in our Lodges, and in the midst of many of our gatherings among the Brethren. This topic has surfaced many times at our Annual Grand Lodge Communications, basically this topic has been discussed in many ways, many forms by all, in all kinds of places. Further, this subject brings out a variety of emotions that covers the entire spectrum of human conditions.



Lets us start by looking at the reality of proficiency, we require it of new inductees whatever degree they are in until he becomes a Master Mason. Why? Is it not as important to be proficient as a Master Mason as it is in the previous two Degrees? I dare say it is not only as important I would venture to say it is more impor-

tant. This notion sends the wrong message, to the Brethren coming through, it goes against the thought that Masonry is a never-ending study, it infers that he has learned everything he needs to know, when we all know the truth is quite contrary to the practice. So I ask of my Brothers to help me understand the reason of why this practice is perpetuated.

Our next level of proficiency we run into is that of the Officers of the Lodge. Our custom practice of progression seems to have lost its meaning over the years with the lack of education in our Lodges, Districts, Zones and State level. We no longer expect much of the Officers if anything at all, and proficiency is one that has suffered a great deal in the last fifteen or so years.

Practices are something that it is almost none

existent in most Lodges compared to what it used to be in yester years not too long ago. To those Brothers and Lodges that continue this great tradition of studying, practicing and learning, I CONGRATULATE YOU, do not give up, we appreciate your effort and you and your Lodge are the better for it.

To those Officers that put no effort and are given a pass for not performing their duties; we pity your inability to take your obligations to heart. Your actions are painfully obvious to everyone although you cannot see them. My Brother the difference is Selfrespect, Accountability, and Honor. Something we promised to work on and improve ourselves, so we can become better men, better husbands, better fathers and better citizens, which is Masonry's promise to the world.

How can we as upright men and Masons demand of the initiate something we as Master Masons and Officers of the Lodges often fail to do? I believe that leading by example is the best lesson we can deliver to the newly initiated Brothers and demonstrate to our Brethren that we take our obligations seriously. Let us live up to our commitments, let us perform our duties, let us restore the faith of those who had faith in us to do the right thing and perform our obligations.

Let us make a commitment to ourselves not too settle for mediocrity, let us deliver the message that business as usual will no longer be accepted. We deserve more and must expect more from our representatives in the Lodge,

District and State level. Also, let us give them the support and atmosphere needed for them to be successful. Success should not be measured by social advancement, good ole boy connection, or sympathy, no sir success is measured by hard work, dedication, performance.

Remember, we the Craft owe certain responsibilities to the success or failure of the Lodge and Officers, because if we fail to make the right decisions, and elect Brothers that are not ready to lead, we fail. If we fail to assist the Officers in the operation of the Lodge when called upon, we fail. If we fail to take active rolls in our Lodges and they fall back in disrepair, we fail. So, we as sideline Masons have to step up take our responsibilities to heart and do what we should always be doing and that is "Masons always rise to the occasion." To my fellow Lodge Officers we have a lot in common, we operate in the same circles, we have the same responsibilities, and we have the same burdens of leadership. I say unto you my Brother that you as a leader and representative of your Lodge, expect certain performances from the Grand Lodge Officers and that is your duty to do so. But remember my Brothers that as Officers of your Lodge you also owe the same performances to your Lodge Brothers that bestowed on you the honor to represent them. Also remember that as Officers of your Lodge you have certain responsibilities to your Brothers and to Grand Lodge that must be performed in order to maintain a properly Chartered Lodge. Please do not take them lightly, you would not appreciate us taking ours lightly either.

Proficiency is for everyone, do not cheat anyone of the learning experience it brings to every Brother. Expect your Officers to do the same in their jobs. Proficiency in the Ritual separates us from a social club to a Masonic Lodge.

The beauty of our Ritual has set us apart for centuries, keep up the tradition, you owe your sons and grandsons this much. KEEP IT ALIVE.

Dear Brothers:

Is this a new way to wear our ring, apron or badges, not really although it may have something to do with it. Etiquette whether Masonic or Societal has certain requirements we as members must use in order to conform with the character of our surrounding.

Etiquette is define as – "rules of acceptable behavior," "the rules and conventions governing correct or polite behavior in society in general or in a specific social or professional group or situation." Sounds like etiquette can apply to us as Masons, you know you are right thus the expression Masonic Etiquette.

As the title says, "Masonic Etiquette, is it contagious?" Is not, but I sure wish it was. Can you possibly imagine if we all practice Masonic Etiquette and that each and every one of us governs ourselves in a correct and polite behavior according to what a gentlemen's standard but more importantly as a Brother Mason.

I can imagine things like that and I am sure you can too if you can do two things act as such and dream. Hope that your faith in your Brothers will carry the day with proper education of what is expected of a Mason. Where can we start? Well remember before anything that you belong to a society of gentlemen engage in a noble undertaking in that we are a Brotherhood of men under the Fatherhood of God.

Let us start with how we dress for a Lodge Communication, because this in itself says a lot about our Lodges and our Fraternity. I know that we say that "is the internal and not the external qualifications of a man" this is what we look at and it speaks about the morality and character of each individual and is entirely true, but is not applicable to our appearance and dress habits.

Back to dress, they way we dress expresses a degree of importance that is place on whatever we are attending, whether it is a department store, hardware, doctor, beach, work, place of worship or Lodge. I know some of us have placed no importance on this matter and maybe they have not put much thought on it. Maybe they like to push the envelope to get attention. Maybe they think is pretentious. Maybe no one has sat down and explained to them the proper decorum that should be the constant care of every mason in a Lodge.

Well Masonic Etiquette calls for us do look, dress and act like gentlemen at all times, it elevates our Lodges, it attracts men of similar thinking, it teaches others how to dress and act like gentlemen since not all of us have received former training in that aspect, but we can learn by emulating those Brothers. For one I am impressed when someone speaks of a Brothers and says "he is a Mason and gentleman"," he epitomizes what a Mason should be" or "if you look up Mason and gentleman you will see his pictures." It would be wonderful if that were said of every one of us. Remember we as Masons are constantly striving for perfection and this one item is equally as important.

So, how do we go about it, changing attitudes is one of the hardest things we have to do, more especially when we have to change ours. Well my Brothers, we have to talk about it, in Masonic Education, passing bylaws in our Lodges, prohibiting Brothers who are mem-

bers or visitors from participating in the proceedings if they are not properly attire. I know you are already saying that is terrible, we don't have enough sideliners and we are going to turn someone away. Well my Brother you post the dress code requirements where everyone can see it, you advertize it on the Trestle Board, on your web site. You explain it to the Brother in the most tactful form. "Dress code" is nothing new to our Fraternity it still exists in many places around the world to the point where nothing but Formal Dress or cut away coats are used. We have gotten so sloppy it has detracted from everything we do, from the way we dress, the way we do our ritual, conduct our business, you see that pervasive attitude that infiltrates all we do and we cannot see the tree for the forest. Stand back my Brothers and look in "DO NOT SETTLE FOR LESS" and you will get the best.

Here is another way that a Lodge can assist its members in achieving this goal. No rocket science here, just another inner tube solution. Look at your local Salvation Army, Goodwill, and Consignment Stores, here you will be able to find suits or sports coats for practically nothing and you can have a few sizes in a coat closet and lend them to the visitor to wear while he visits the Lodge. Much like restaurants, which require coats in their dining room, and do not want to turn the customer away. Another way this can be achieved is by asking Brothers to donate these items to the Lodge, or to another Brother in the Lodge. The possibilities are endless like in so many of our situations we find ourselves in, if we just stop and think for a minute or two.

Brothers coming from work, not a problem, he may be able to change at work, or at the Lodge, he can leave a set of clothes at the Lodge for him to change into, or simply bring it the night of the meeting, not too much to ask.

Conduct in the Lodge, wishing to speak, not a problem. Arise unto your feet and wait to be recognized by the Worshipful Master. NEVER speak from your seat is not only improper is highly disrespectful. Another Brother using the floor no problem, either wait until he is finish and then stand, or simply stand and wait until he is finish be or recognized by the Master. Never address another Brother in the Lodge without permission of the Master, all conversation in the Lodge must be directed through the Master. No loud talking or shouting, no bad language, no disrespect of any kind. After all we are gentlemen and more importantly Masons.

Wearing of the Apron. In Florida, we wear our aprons on the inside of a normal coat; if we are using a double-breasted coat, we use them on the outside. Do not correct visiting Brothers; they are wearing their aprons, as it is their practice in their jurisdiction. Past Masters in Florida, although there is no specific design for a Past Masters Apron in our jurisdiction, two things are clear. One is the Gold trimmings on the Apron or Jewels are reserved for Grand Lodge Elected and Appointed Officers and Past Grand Masters and two is that the apron be in good taste to compliment your station, humility and proper decorum should be your dictates in that selection.

The Masters Hat, this like the apron leaves wiggle room and many times it seems to be pushing the envelope as previously stated reasons explained the situations. So lets use a little common sense. Masonic Etiquette tells us about no straw hat or ball cap, and for those that like to push the envelope this may mean anything goes, but my Brothers remember the usages and customs of our Fraternity, which go back nearly four centuries, so good taste, not wild themes should be the order of the day. Also the funeral services call for a black hat, therefore if you are Worshipful Master and need a hat obtain one that is Black, this way you can use it both in Lodge and in Funeral Services if called upon. No style of cap whatsoever is proper to be worn and always let good taste and manners serve as your rule and guide. Most commonly used coverings are Fedora's, Top hats and Derby's as well as a nice Stetson.

As everything done in good taste, points you out as a mark of distinction. It is not just what you wear but how you wear it that makes a difference. Is not the expensive suit that makes the man, is how he wears it? If he is an untidy and messy dresser no matter how expensive, the suit is he will be just that untidy and messy, but a gentleman can simply dress smart and neat in any type of suit or sports coat regardless of the cost of the garment. Decorations and adornments on the clothing of badges and pins should also be use with extreme moderation, the fewer the better to avoid looking gaudy and detract from your clothing and appearance. If your wear an American Flag on your lapel it should be on your left side closest to your heart, this is proper etiquette for wearing the national emblem.

Well good manners or proper etiquette as Masonic Etiquette are long subjects and takes time to learn about them and understand the proper conduct among society and different aspects of clubs or institutions more especially ours.

I hope this has peak your curiosity and causes you to get better informed as well as informing those Brothers close to you. Remember all we are trying to do is improve ourselves in Masonry, be the very best Mason and gentlemen you can be, and help bring others along with you. Let us take the inspiration of raising those less informed in the social practices of proper manners and decorum. In our politically correct society of today we tend to bring things down to meet those less informed, less educated, less fortunate, dummying our society down. I say let us take the approach that made this country great and that is to teach those who are willing to invest time by lifting them up to a higher level, where they are better informed, better educated, more fortunate and society as a whole will be better serve when we are smarter, sharper and more productive, and not the other way around.
