

### THE MASONIC BLUE SLIPPER

Are you familiar with the Masonic blue slipper? It is a small lapel pin in the shape of a blue slipper. Over the years it has been my habit to ask my wife and my daughters to wear one of these slippers on a coat or dress when traveling alone away from home. What is the meaning of this blue slipper and why should female relatives of Masons wear one?

Some 50 or 60 years ago, while I was still living at home, a widowed lady who was a cousin of my Dad's came to visit our home. She vacationed with us for several weeks every summer. She always wore this type of pin-The Blue Slipper. Her doctor husband was a Mason. The pin that she wore made a lasting impression on me. Through my curiosity and questioning, she told me it was a Masonic pin and served to identify her as a Masonic widow. She declared that Masonic men gave her extra attention while traveling, especially on the railroad (such as conductors, etc.).

To find out the meaning of this pin, let us go back in history to Boaz' time, in the Book of Ruth. It will be remembered that Elimelech, his wife, Naomi, and their two sons, Mahlon and Chilon, fled to the land of Moab to escape the famine in their homeland of Bethlehem Judah. Things went well for a while. Then life fell apart for them. Elimelech died. The two sons married Moabite girls-Orpha and Ruth. Again tragedy struck. Mahlon and Chilon died. This left Naomi a widow in a foreign land with two widowed daughters-in-law from the land of Moab.

In time of trouble, people think of home and more importantly of God. Naomi found out that the famine back home had subsided, and there was grain and food again. So she confided with Orpha and Ruth that she would journey back home and be among her kinsmen.

Certain laws, rules, or customs governed her thinking at this time. Of first consideration was the fact that Naomi was too old to bear a son for her daughters-in-law to marry. Even if she could, the daughters-in-law would not wait for the son to grow up. So the girls should remain among their own people. The girls resisted and started to go with Naomi. Orpha was finally convinced she should stay in Moab. But Ruth remained steadfast and went with Naomi to her homeland.

Naomi and Ruth arrived back in Bethlehem-Judah at harvest time. The Scripture passage on which this is based is well-known. "And Ruth said, Intreat me not to leave thee, or to return from following after thee: for whither thou goest, I will go; and where thou lodgest, I will lodge: thy people shall be my people, and thy God my God: Where thou diest, will I die, and there will I be buried: the Lord do so to me, and more also, if ought but death part thee and me." This passage of Scripture is unsurpassed as a declaration of love and devotion of one person for another. It has been said that it would made a good marriage vow. But, to me it is a different type of devotion.

Naomi also had to take into consideration another law. When Elimelech died, his next of kin was duty bound to redeem his possessions and take care of his widow and her family. Since Naomi was getting old, Ruth tried to earn a livelihood. While gleaning in the fields, she was seen by Boaz. And when he found out about her (that she was Naomi's daughter in-law, etc.), he arranged special treatment for her. She could work with his girls in the field, and the young men were warned not to bother her. Since Boaz was not married and was kin to Naomi, Naomi decided that she

should somehow make Boaz understand his duty to Elimelech's family. So Naomi advised Ruth to bathe and anoint herself and go to the threshing floor after dark and lay at the feet of Boaz. Boaz awoke at midnight and discovered her there. So as not to create a scandal, he gave her some barley and asked her to leave before dawn so that watching eyes would not recognize her.

Business among the tribe of Bethlehem-Judah took place at the gate of the city. So Boaz sat down at the gate the next day because he knew there was a kinsman more closely related to Elimelech than he. So when the kinsman came by, Boaz called him aside and asked 10 men of the elders of the city to sit with them. Boaz bargained with his kinsman. The kinsman said he would redeem Elimelech's property. But, when he found out that he would have to take care of Naomi and Ruth, he reneged and told Boaz he would not redeem or protect Elimelech's interest. He would leave it to Boaz. The passage from Scripture for these events is the following: "And the kinsman said, I cannot redeem it for myself, lest I mar mine own inheritance: redeem thou my right to thyself; for I cannot redeem it., Now this was the manner in former time in Israel concerning redeeming and concerning changing, for to confirm all things; a man plucked off his shoe, and gave it to his neighbor: and this was a testimony in Israel."

So the kinsman drew off his shoe and gave it to Boaz. Boaz held it up for all in the gate to see. He asked them to be witnesses that he became Naomi's protector, Ruth's husband, and a redeemer of Elimelech's property. So, today we have the little blue slipper as an emblem of the protective influence of Masons for their wives, widows, and daughters.





At our August 10th Sunday dinner, Mrs. Jeanette Dunston, wife of Brother William (Bill) Dunston, Jr. who was recently called to a higher lodge, was presented by W.: Bill Green a widows pin and certificate from the Grand Lodge of Florida. Brother Dunston was a Mason for 51 years. Mrs. Dunston is active in Leesburg Chapter No. 84 of the Order of the Eastern Star, and at each Sunday dinner decorates the dining hall and greets arriving guests.

### **MASONIC EDUCATION & DISCUSSION**

### **CEMENT**

### Author—Unknown

The trowel is an instrument used by Operative Masons to spread the cement which unites a building into one common mass or whole." So says our ritual. From months of use spreading and smoothing the cement, the trowel becomes worn and is replaced.

After many years of labor, the Master workman wearies and lays down his tools either in retirement or to answer the last roll call. However, though both the trowel and the workman have served their purpose and been discarded, the great cathedral erected to the Supreme Architect of the Universe, the warehouse dedicated to business, the modest cottage sheltering the workman and his family, or even the house of confinement established for the safety of the citizenry continue on down through the years as a "solid Mass" of architecture due to the strong and stable bond of cement with which the building material was united.

The cement to which our ritual refers is a mortar consisting of a combination of several materials. One of these is a fine, gray powder which from long usage is known by the trade name cement. This cement is in reality rock of a certain type, heated to an extreme temperature or actually burned in a fire until it loses all its impurities and crumbles into the fine powder we know as cement.

The second ingredient is sand. Sand is also rock that has been dislodged by glaciers or other forces, perhaps as far in the past as the ice age, tumbled down mountain streams, through falls and rapids and on into rivers which sweep it to the bays and gulfs and so down to the sea, tumbling it and washing it until it is ground into the fine particles we know as sand. One other material is added to bind together the cement and sand.

This third material is water, pure unadulterated water, which has long been the symbol of life, for without it nothing living can exist. These articles are mixed in the proper proportions forming the mortar used by the Operative Mason and referred to in our ritual as cement. The ingredients must be pure, the cement fresh and dry, and the sand clean and sharp and the water free from impurities if the structure in which it is used is to stand through the years as a monument to the workmanship of the builder.

"But it is used symbolically for the far more noble and glorious "purpose" of spreading the cement of Brotherly Love and Affection." Here the educated Brother associates the mortar used in a building with those truly Masonic virtues, Brotherly Love and Affection. It seems quite certain that our Brother realizes that these Masonic attributes must not merely be word pictures, pleasing to our senses, but that if our Masonic structure is to endure, the Brotherly Love and Affection which cements it together must be as solid, sturdy and durable as rock.

As the rock of which the Operative Mason's cement mortar is composed, it must be devoid of all impurities as if tested by fire, clean as by the continuous washing by the waters of life, and joined into one binding and abiding cement by the life we so willing share with our Brother.

The trowel may be worn and discarded, the Master Mason may have joined the Celestial Lodge above, but the cement they together have spread lives on forever and is the cement to which the ritualist refers when he says: "(the cement) which unites us into one sacred band or society of friends and brothers--a Temple of living stones, among whom no contention should ever exist, save that noble contention, or rather emulation, of who can best work and best agree."

### **DEONTOLOGY**

This past spring the Midwest conference on Masonic Education met in Omaha, Nebraska. It was an exceptional conference, and everyone who was at the conference was glad he took the time to attend.

One of the workshops at the conference, "Virtue Ethics," was conducted by Brother and Dr. Nelson Stone. This workshop was all too short, (just 30 minutes,) but then this is one of my favorite subjects, Brother Stone had a very difficult task to delve into ethics and philosophy as they can be applied to Masonry in so short a time, but he was able to do it, and he made it extremely interesting. Delving into ethics and philosophy and how they apply to Freemasonry is a very worthwhile thing to do. I like these subjects not because I am so well versed in it, but because I want to understand it better.

Virtue Ethics is a peculiar kind of ethics in that it tells you things like 'be a good person' or 'maintain relationships and are for other people' without providing a clear idea of how to do it. ""This is a problem that philosophers refer to as 'contextualism.' Virtue ethics does not make universal claims. E.g. the ethics of the right thing to do varies from context to context.

When I mention about understanding as it relates to virtue ethics and philosophy and Masonry I remember something Rabi Benjamin Blech says in one of his lectures about the people receiving the Torah from God; he says their response was "We will do and we will hear." Meaning that they first committed to do first and then to begin to understand. Remembering that reminds me of the ritual of Freemasonry; the candidate in the degree is told that in order to join in the great and good work of Freemasonry it is necessary for him to make a statement and promises of future actions, as all Masons before him have also done, before he begins to understand; every Freemason has been willing to do that; Masonry is a fraternity of action: After the action of our promises we then begin our journey of understanding.

One of the topics mentioned in the workshop on Virtue Ethics was Deontology, which is different than virtue ethics: [Deon-tology] this is the theory of moral obligation or commitment, which applies very well to the obligations of the degrees in Freemasonry. If you were to study deontology much of what you will learn will have a special significance to you as a Freemason. The word 'deontology' comes from the Greek word 'Deont,' which means that which is binding or needful. The word is also influenced by the words 'Dien,' and 'Logy;' 'Dien'- bind; 'Logy' – discourse or expression.

Deontology is about duty. The term 'deontological' means 'duty based.' Any moral theory that is deontological is one that focuses on duty; it doesn't matter who or what that duty is to, so it applies very well to Masons being duty bound to fulfill their promises no matter who they are made to, even to themselves. The Philosopher Emmanuel Kant is one who was a proponent of deontological theories. According to Kant deontology was all about following absolute rules; to do one's duty. A definition of duty is; something you are required to do whether you want to or not.

Following rules is an interesting subject in itself, which you may want to study. In the obligation of the Masonic degrees there are things a Mason promises to do, and not to do. Rabi Benjamin Blech says in referring to the many Mitzvot in the Torah that the don'ts are more important than the do's: he explains that the 'don'ts' prevent us from making grievous errors, while the do's guide us down a proper path of conduct. The Masonic obligations also contain various do's and don'ts. For our own enjoyment each of us might enjoy reviewing the obligations, and maybe the charges, of the three degrees of the Blue Lodge, just to refresh our memories about the do's and don'ts of Freemasonry.

When we think of deontological theory we might also want to learn about 'motivist' and 'consequence' theories: To explain briefly the 'motivist ethical theory' says that the rightness or wrongness of an action depends, in its entirety, on the motive from which the action was done. e.g. why was the action taken? The 'consequence ethical theory' says

the rightness or wrongness of an action depends entirely on the effects that the action has; e.g. what are the results of the action?

Philosophers who hold to the deontological ethical theory say that it differs from the motivist and the consequence theories in that "the rightness or wrongness of an act depends neither on the motive from which an act was done nor upon the consequences of the act – but solely upon what kind of act it was." Because of the stress on obligation and duty deontological theories are also called 'Duty Ethics.'

Philosopher Emanuel Kant's ideas on deontological ethics and morality have been summed up to just a few simple items which include; always tell the truth, and always keep your promises. "Kant also believed that the only thing that is totally and completely good without exception is a good will." What Kant meant by 'good will' was that our desires, the things we wish and hope for, must be good. He believed that only the 'good will' is absolutely good, thus "just because a wrong or evil act might turn out good in the end [I'm sure you can think of examples of this kind of action] doesn't mean that the act becomes good. "The moral of this is that you can't just look at behaviors or outcomes to see if an act is right or wrong." Deontology, according to Kant, "totally rejects out comes as a way of judging acts; because things can turn out well even when we don't intend them to, and things can turn out terribly, even when we mean well!"

### S.M.A.R.T

Many Lodges are "dark" in the summer months, but even so some Lodge officers use the summer to asses how the Lodge is doing, and to plan for the balance of the year. With this in mind, here are some things that might be helpful. I like this acronym about **goals**: S.M.A.R.T.

- 1. [S] Specific
- 2. [M] Measurable
- 3. [A] Achievable
- 4. [R] Relevant
- 5. [T] Timely

When it comes to goals there are steps involved to achieve them; a person needs to have the determination to see them through. All this has been summed up as the <u>4-D Goal Model</u>.

Desire = which is the big goal.

Dedication = which is the measurable goal.

Discipline = which is the calculated steps.

Determination = to stay the course despite the obstacles, which are certain to occur.

Finally there are three S's of Success

1. <u>See it</u>: See your Lodge as the successful Lodge it should be; see the goals accomplished;

believing is seeing.

2. Start: Act, do something. You have 24 hours to act on a good idea. Ideas not acted upon,

or not acted upon properly, are either bad ideas or lost opportunities.

3. <u>Sustain the effort</u>: Overcome obstacles, and refer to the first "S."
