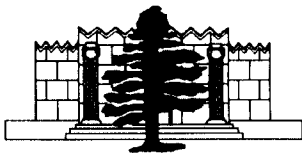

Our May 2nd Executive Board will be at the home of Yvonne Jerman. Remember you will always be welcome to come to the Executive Board Meetings.

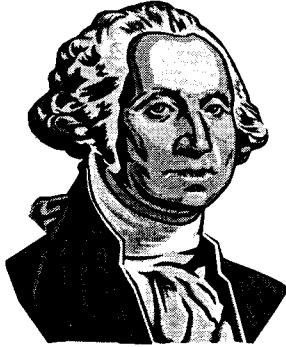
Several of our members have been under the weather lately and we wish for them a speedy recovery and look forward to seeing them at our meetings. Remember warm weather is just around the corner.


