**Instructions**

- Every item on the form must be answered. The printed part of this form shall not be changed, but the Grand Secretary shall arrange this form for printing.
- The petitioner must show his full name where required on the form, and he must himself sign his name in full. If he has no middle name, then put NMN. If he has an initial only, then put the letter and circle it, thus (B); example, "John (B) Smith," or "John NMN Smith". *Print or type FULL NAME where first required on the line at the top of this form.*
- The *correct* last names must be shown. Show the *first, middle, and last names before marriage*. If not married, show *single, widower, or divorced*.
- The residence of a petitioner is the place where he ACTUALLY RESIDES. Do not give a post office box number as residence. Give house number, street, city or town, and state. If the petitioner was born, or resides, in an area where houses and streets are not identified by names or numbers then he must answer by a clear statement such as, example, *R.F.D. No 1, on State Highway 18, about three miles north of Raleigh, NC.*
- Concerning occupation, do not use *clerk, salesman, manager, solicitor* or any other indefinite term, but state also the particular kind of business or employment such as *office clerk (insurance, fire or life, retail shoes, etc.); salesman (retail or wholesale, groceries, hardware, etc.); manager (local insurance agency, retail coal, etc.); or solicitor (newspaper advertising, subscriptions, etc.)*
- The references should be persons who know the petitioner well; they should be, but are not required to be, Master Masons. (NC Form 17)
