Autumn has officially arrived, and soon the leaves will change and display their wondrous colors. This summer has been particularly brutal for most of the northeast, with excessive heat and drought conditions. As I watched my newly planted grass burn in the summer sun, I was amazed to see some shrubs and plants had the endurance to survive.

Although we have had recent rainfall to bring some relief, only time will tell if the rainfall is consistent enough to pull us completely out of the drought.
