Masonic Presidents: George Washington by Bill Harvey, PM

Brothers, it is well known that several of our Presidents were Masons. I have done

a little research and have come up with some information on these great men. This issue will start with George Washington, one of our greatest Presidents and founding father of America.

Washington was initiated, passed and raised in "The Lodge at Fredericksburg, VA., (now No.4 on the Virginia Register) on Nov. 4, 1752, March 3 and August 4, 1753. He was made an honorary member of Alexandria Lodge No. 39, June 24, 1784. When his Lodge gave up its Charter under the provincial Grand Lodge of Pennsylvania to accept one from the Grand Lodge of Virginia and become No.22, April 28, 1788, Washington was named as Charter Worshipful Master, and was re-elected Master December 20, 1788. He was made an Honorary Member of Holland Lodge No. 8, New York, 1789.

His Masonic activities and visits were many; his letters to and about Lodges and Masons fills a volume. He was the only President ever to be Master of his Lodge during his incumbency.

The cornerstone of the United States Capital was laid by Washington, with Masonic ceremonies, on September 18, 1793, at the request of Maryland Grand Master pro tem. He died December 14, 1799, and was buried with Masonic honors by Alexandria Lodge No. 22 on December 18th. The Lodge later changed its name to Alexandria Washington Lodge No.22.

To his memory and fame the Masons of the United States are erecting the mightiest stone monument ever raised to honor any man; this memorial stands on Shooter's Hill just outside the city of Alexandria, Virginia.



Masonic Presidents: James Monroe by Bill Harvey, PM

James Monroe, 5th President (1817-1824), was born in Westmoreland

County, Virginia April 28, 1752. The original records of Williamsburg Lodge No. 6, Williamsburg, Va., show (Nov. 6, 1775) that he was "recommended" as a fit person to be

admitted a member of this lodge and the motion recorded. On Nov. 9, 1775, he was "preferred, received and balloted for; passed and accepted and entered an apprentice". The curious reader will note that he was not quite seventeen years and six months old at this time!

His dues were paid through October 1780, but no record shows as to when he was raised. Tradition states that he received the Master's Degree in a Military Lodge during the revolution, and also credits him membership in Kilwinning Cross Lodge No.2, Port Royal, Va. Little is known of his Masonic life. He visited Cumberland Lodge No.8, at a meeting especially called to receive him in Nashville, Tenn. on June 8, 1819. He died in New York, July 4, 1831.



Have you met? Mark Galloway by Bill Harvey, PM

This month's mason being featured is Bro. Mark Hamilton Galloway. He was

born on Feb. 15, 1948 in Wheeling, West Virginia, just across the Ohio River from his hometown. After he graduated from High School, Mark attended and graduated from Ohio State University in 1976. Uncle Sam needed Mark to fill a spot in Vietnam, so he was drafted in 1969 and served in the 101st Airborne Division till 1971. After basic training (he became an infantryman) he went straight to Vietnam for a year. Upon his return to the U.S., he was stationed at Ft. Riley, Kansas.

Mark's first wife passed away while in Ohio.



He went to Vietnam as an Entered Apprentice and finished his Fellowcraft and Master Mason upon his return to America. He held no office as a Mason in Ohio. After he transferred to Suburban 740, he started in line and worked his way up to Master in 2009. In 2010, Mark served as District Deputy Grand Master, Dist. 13, for Bro. L. Todd Eastham, Worshipful Grand Master of Kentucky. He is a dual-member with St Matthews 906. (Author's note: St. Matthews 906 and Suburban 740 voted their support of Bro. Mark's running for Grand Junior Warden, Grand Lodge of Kentucky),

Mark belongs to the Valley of Louisville, Scottish Rite, 32nd Degree, Senior Warden of Knights of St. Andrew of Scotland at the Scottish Rite, member of Kosair Shrine, York Rite Eureka Chapter 101, Hiram Counsel #70, Knights Templar, Eastern Star (Southern Star 154), Past Masters Society, Past Masters Unit (Shrine), and Jefferson Commandry #52. He also has received the Grand Cross of Color (Rainbows). He is an Usher at Southeast Christian Church.

His hobbies are old cars (he has 2, a Studebaker and an Avanti), writing (he has a book on the Beach Boys due out next year), and the Masonic Lodge. Mark wanted to say that it was good to belong to Suburban Lodge as they meet each week. It keeps one very active if you belong here.

I want to thank Mark for his helping where needed at Suburban, whether it be on the Hall Association, working at the fish stand on Saturdays, or taking part in the degree work. We need more members who are willing to pitch in when needed to make our Lodge the great one that it is.



Kit Carson

Located in Northern New Mexico at the foot of the Sangre de Christo Mountains is a village named Taos.

In the center of town, just two blocks east

of the Plaza stands a plain adobe structure. This old structure is now considered a National Historic Landmark and listed on the State and National Register of Historic Buildings and Properties. The typical southwestern style dwelling features territorialstyle trimmed windows and doors, vitas on the ceiling and is authentically furnished in Spanish Colonial and Territorial styles. Known as the Kit Carson Home and Museum, it features exhibitions on the life of Kit Carson, educational programs, and museum staff members who offer interpretative and informative tours.

General Christopher "Kit" Carson was a member of Montezuma Lodge No. 109, A.F. & A.M., the first lodge in the region and chartered by the Grand Lodge of Missouri on May 8, 1851. Just a year earlier, New Mexico became a Territory, (which included present day Arizona). Later, when the Grand Lodge of New Mexico was organized, Montezuma No 109 became Montezuma No. 1, but not until August 7, 1877. (By the way, New Mexico didn't even become a state until 1912!) Owned and operated by Masons, this gem of a museum is worth the visit.

The Masonic Lodge in Taos, Bent No. 42, is named after Charles Bent, who was the first Territorial Governor of New Mexico (and Mason, of course!) This lodge was chartered by the Grand Lodge of New Mexico on October 20, 1909. It was originally chartered by Missouri as Bent Lodge No. 204, but the charter was surrendered during the Civil War. Carson served as both Junior and Senior Warden of this lodge. The lodge purchased the property to create a memorial to Carson and has continually worked to restore its distinctive historic appearance.

THE KIT CARSON HOUSE - was originally built in 1825. Carson bought the house in February of 1843 when he married Josefa Jaramillo, who was the daughter of a leading Taos family. The home is a single story adobe in the shape of a "U" and their permanent home for the next 25 years. Family tradition says that Carson bought the house as a wedding gift for his young bride and records reveal that most of their eight children were born here. Opened as a one room museum in the early 1900s, the site has developed into a top attraction in Taos. It was expanded in 1954, and by the year 1963, the structure was selected for National Historic Landmark status. By 1966 it was placed on the National Register of Historic Places. The house and museum properties consist of the original threeroom, 21-viga home of Kit Carson and his

wife Josefa, purchased in 1843, as well as an 1830-1856 structure know as the Romero House.

Time and the elements have worn on the structure-particularly the adobe. (For those who don't know, "adobe" is not just a company that develops computer software products: it is a building material made from sand, dirt, clay, and water, mixed with a fibrous or organic material such as sticks or straw). The "mud" is shaped into bricks and dried in the sun to form earth-tone bricks. One of my favorite parts of the home is a period patio. The rooms of the home surround an inner courtyard, characteristic in the Southwest. In 2005, the Masons put over \$300,000 into stabilizing the foundation and rehabilitating the roof. But, as with any historic property, more work continually needs to be done to maintain the home.

Christopher "Kit" Carson lived the life of a real American frontiersman. He has more than a legendary comic book character of the wild west. Born in KENTUCKY in 1809, he spent most of his childhood in Missouri and left home at an early age to become a trapper. He traveled west to Taos where he went on many fur trapping expeditions.

In the 1840s, Carson served as a guide and scout for John C. Fremont in the American West. These expeditions afforded the opportunity to explore and map the geography of the West. (By the way, this is where Kit became "famous" from the widely-read reports of the expeditions.) Over his lifetime, he was a hunter, explorer, scout, Indian agent, rancher, soldier, and national hero.

Carson died in 1868, one month after his wife. His will stipulated that everything was to help provide for his children. This included between one hundred and two hundred cattle, seven yoke of steers and two ox wagons, four horses and one carriage, the furniture in the home in Taos, and several pieces of land in Taos (which were to be rented from year to year to the highest bidder and the sum used to support his children).

Because his estate was liquidated to support his children, there are very few of Carson's artifacts that remain in existence. Fortunately, his Masonic apron survived, and it was donated to the Grand Lodge of New Mexico in 1906 by a Colorado Mason, Dr. J. C. Slack. The Doctor acquired it when he treated Carson's daughter, Mrs. Rosa Squires, in 1894, when she was sick and in "destitute circumstances". He took care of

her without of hope of fee or reward. In return, she insisted on giving him her father's Masonic apron, knowing that he was a Mason.

The other unique artifact of Carson's remaining is also in the possession and care of the Masons. That is his rifle. Now, this is not located at the museum. It is held in a safe, but they do have a reproduction! The rifle was presented to Montezuma Lodge No. 109, of Santa FE, New Mexico, soon after Carson's death.

The Kit Carson Home and Museum is a historic structure that that local Masons recognized as a treasure of American history, and it is definitely a building worth preservation. Stop in and see for yourself. Visit the Kit Carson Home and Museum, a 501 (c)3 charity operated by Bent Lodge No. 43, AF & AM, Taos, New Mexico. Check out their web site:
